All changes made during IYC open enrollment will be effective January 1, 2017.

HEALTH PLAN SERVICE AREA Compare Plans

- Is my health plan available in 2017?
 - Anthem Blue Preferred Southeast, Arise Health Plan – Aspirus Arise, and WEA Trust South Central (covering Dane County) will no longer be available.
 - Look at the map to ensure my plan is covering services where I live.

HEALTH PLAN PROVIDER NETWORK Compare Plans

- Is my primary care doctor still covered by my health plan?
- Are the other members of my health care team covered, too? (e.g. nurse practitioner or specialist)

HEALTH PLAN REPORT CARD Compare Plans

- How many stars did my plan receive overall?
- Does another plan look more appealing to me?
 - Check the map to see which plans are available in my area.

DENTAL Compare Benefits

- Does my employer offer the Uniform Dental Benefit?
 - If yes, do I want this basic coverage? (Basic coverage is available if I elect health insurance with the Uniform Dental benefit; I may also elect health insurance without dental.)
 - Verify that my dental provider is covered with Delta Dental.
- Does my employer offer another dental plan that is not administered by ETF? Am I interested in that?



SUPPLEMENTING YOUR COVERAGE Compare Benefits

- Does my employer offer any supplemental dental, vision, long-term care or other coverage?
- Find out if the monthly costs will change for any current coverage.
- If I don't need my current coverage next year, figure out how long I have to cancel it.

PRE-TAX SAVINGS - FLEX SPENDING ACCOUNTS (FSA) Compare Benefits

- Find out if my employer offers any pre-tax savings options.
 - If so, how much should I set aside for 2017?

TAKE ACTION Enrollment
